

## **LIMITED WARRANTY for REBAR CUTTING & BENDING MACHINES**

Rapid Tool Australia Pty Ltd ('RapidTool') warrants to the original purchaser that RapidTool Rebar Cutting & Bending Machines ('Product') will be free from defects in material and workmanship under normal use for a period of one (1) year from the date of original purchase at retail.

If the Product should prove to be defective in material or workmanship within the warranty period, an authorized service centre will at its sole option repair it or replace any defective part or parts, without charge. All transportation costs shall be prepaid by the customer.

Refurbished parts may be used to repair the Product. Any replacement part provided will carry a warranty for the balance of the period of warranty applicable to the part it replaces.

The following parts are not covered under this warranty:

Cutter Blocks, Carbon Brushes, Power Cords, Switches, Foot Pedals & Product accessories.

For an evaluation of whether a defect covered by this warranty exists, and/or to obtain warranty service, you must take or deliver the complete Product with transportation prepaid to an authorized service centre, together with proof of purchase. This warranty is exclusive and in lieu of all other warranties, including any warranty of quality, expressed or implied, and including any warranty of merchantability, or any warranty of fitness for any particular purpose.

This warranty gives you specific legal rights and you may also have other rights which vary from territory to territory. Furthermore, the terms in this limited warranty statement, except to the extent lawfully permitted, do not exclude, restrict, or modify, and are in addition to, the mandatory legal rights applicable to the sale of the Product to customers.

Please note warranty is not covered in the following situations:

- Where the Product has been used for commercial reinforcing steel (rebar) production purposes
- Where the Product has been used for any other purpose than cutting or bending reinforcing steel (rebar)
- For replacement or repair of any damaged Motor components as a result of not replacing worn Carbon Brushes
- Where the Product has not been installed, operated, maintained or used in accordance with RapidTool instructions or specifications provided with the Product

- Where the factory-applied serial number has been altered, damaged or removed from the Product
- Where damage, malfunction or failure results from alterations, normal wear and tear, accident, misuse (for instance, use in rain), abuse, fire, liquid spillage, mis-adjustment of customer controls, use on an incorrect voltage, power surges and dips, thunderstorm activity, acts of God, voltage supply problems, tampering or unauthorised repairs by any persons, use of defective or incompatible accessories, exposure to abnormally corrosive conditions or entry by any insect, vermin or foreign object in the Product
- Where repairs have been made or attempted by anyone other than RapidTool and its authorized service centres; or where alterations have been made to the Product using parts that do not meet RapidTool specification, size or quality; or the Product has been used continuously despite partial failure
- Where damage occurs during transportation, installation or while moving the Product
